## What is a Will and Do You Really Need One?

Your will is a written document, signed by you and by two or more witnesses. In some states, your signature must be witnessed by a notary public.

If you do not have a will, the court will follow state law for those without a will. Many of the court decisions might be completely contrary to your desires

For example, without a valid will, a judge might choose guardians for your minor children, select trustees to manage your property and even award property to your distant relatives. With a valid will, you can choose who will inherit your property and who will administer your estate as executor or personal representative. If you have minor children, you can choose a person to raise your children. A valid will is an essential part of transferring your property at the right time to the right people at the lowest cost. Without a valid will, costs, delays, and the probability of expensive conflicts and processes increase.

How can I use my Will to spread the Gospel? One of the simplest ways for you to make a future gift to a charitable organization is through your will.



Here are several ways you leave a gift to benefit The New Jersey Conference Department of Planned a ministry in your Will.

- You can leave a bequest of a fixed dollar amount to your church, the NJ conference, your local Adventist school, or another charitable institution of your choice.
- You can also give a percentage of your estate, which allows you to divide the remainder of your estate (leftover assets after all debts and For help getting started with estate planning, including gifts paid) regardless of its size.
- Your gift can be contingent that is, the funds will go to a certain individual if that person at www.njcsda.org/trust-services survives you. If not, they would be paid to the charitable organization of your choice.
- An alternative is to create a trust through your will, which would pay an income to a beneficiary for life, with the remaining principal to be given to the charitable organization at the time of death. Usually, a gift without restriction is the most useful because it allows charitable organizations to apply the funds to the most pressing needs. But you also have the right to specify in your will how the funds are to be used. Many people desire to leave funds for evangelism, youth ministries, or other causes that are close to their hearts. If you wish to do this, you are urged to consult with the leadership of the charitable organization before you execute your will to make certain the conditions are ones the charitable organization can meet.
